Federal Program Updates

- Pinellas County Schools has received preliminary Title II and Title IV allocations for school year 2021-22. Most LEAs may expect a slight reduction in their Title IV allocation for 2021-2022.
- Title II award notification received. Title IV award pending.
- Final allocations are typically received from DOE in late January.

IDEA: Parentally Placed Private School Students with Disabilities

Ensures that all children with disabilities, ages 3 through 21, have the right to a free appropriate public education designed to meet their individual needs and prepare them for employment and independent living.

Individuals with Disabilities Education Act - IDEA

Federal legislation provides for special education and related services to students with disabilities.

- District has a Child Find responsibility to identify disabled students.
- A proportionate share of IDEA funds are set aside for disabled students enrolled in nonprofit private schools.

Child Find Private School Students



The district where the private school is located is responsible for evaluation and provision of services through a Service Plan (SP) to students attending not-for-profit private schools if available; home zone school.



The district where the student resides is responsible for the evaluation of students *Note: Referrals are made by the parent* attending for-profit private schools.

Parentally-Placed Private School Students with Disabilities (PPPSSD)

Services

- No individual right to services under IDEA; not entitled to FAPE (Free Appropriate Public Education)
- PPPSSD have no entitlement to receive special education and related services from the public school district
- Public School Districts are not required to develop a Service Plan for every PPPSSD.

...the *group* of "parentally-placed" private school students with disabilities with equitable participation in services funded with federal IDEA funds


Consideration of Services

- When a parent requests services and district can provide the services, an SP meeting must be held.
 - Required participants
 - School administrator or designee
 - Teacher from the private school



Determining What Title III Services to Provide Appropriate Title III services are determined based on the needs of the identified ELs in the private school

All services must be supplemental in nature as well as secular, neutral, and non-ideological

Examples of Services

- Administration of language assessment for identification of ELs and for evaluation of services, includes test books and teacher training
- Participation in district-sponsored professional development
- Virtual Tutoring of ELs
- Purchase of supplemental materials and supplies

21st Century Attendance



According to the 21st Century guidelines, students in the program are expected to attend 3 days per week, unless an arrangement has been agreed upon with the program manager.

Absence Defined:

Student who is not present in class at least 2.5 hours of the class period shall be counted absent from the class. To be counted present for the after school day, the student must have attended the regular school day for at least 3.75 hours.

Excused Absences

Absences are permitted for the following reasons:

- Student is ill or injured
- Major illness in the student's immediate family
- Death in the Family
- > Student attend religious event
- Student has been subpoena by the courts
- Student has a medical or dental appointment
- Student is suspected of having communicable disease

21st Century Policy & Procedures

Student Selection:

• Students in grades 3–5 are eligible to participate in the program. The program is free of charge to all eligible applicants on first come first serve basis. There are 60 slots per school and in order to be considered the parent/guardian must fill out the enclosed application and submit it to the front office of the designated school or fax it.

Days of Operation & Hours of Operation:

• The days of operation will be Monday – Thursday during the summer; times vary depending upon the school.

Student Discipline:

• Student discipline will be handled by site coordinators, teachers, and program manager. Students are expected to follow the guidelines and procedures and any discipline issues will be handled via the levels described below. Please note that depending upon the circumstances, the program administration has the right to dismiss student due to egregious behavior at any time after notification to the parent.

- Level One Verbal Wa
- Level Two
- Verbal Warning with students
 - Discussion with parent/guardian possible meeting Student suspended from 21st century iClass up to 3 or more days
- Level ThreeLevel Four
- Program Dismissal– Student will be removed from the program

The Needs Assessment


- Required for determining students' needs as well as professional learning needs for staff
- Used for development of the district's Title II and Title IV applications
- Completed and submitted <u>prior to</u> participation plan

Title II Travel Guidelines

Travel and registration expenses incurred by private school staff to attend conferences or participate in other professional development activities that enhance and expand knowledge and skills will be reimbursed from Title II Part A funds <u>to individual</u> <u>travelers, but not to private schools</u>.

Travelers must complete and submit a Pinellas County Schools travel reimbursement form to the private school administrator for approval signature, and forward to the Federal Projects office for review and authorization of expenses.



Title II Travel Guidelines

Out-of-State Travel -- Limited

Out-of-state travel may be allowable if the services requested are reasonable, necessary and meet the intent and purpose of the grant program. No later than 30 days prior to the travel, a justification must be provided to the program office for preapproval. The justification must include the purpose for the travel, why it cannot be provided within the state of Florida, the projected number of attendees and a cost breakdown (registration fees, hotel, per diem, car rental/airline ticket, etc.) of the travel. The number of attendees requested shall also be reasonable.





Title IV Guidelines

Private schools may access any of the professional development activities described for Title II, using Title IV funds. The key difference is that reimbursement of Title IV funds is made to the school, while reimbursement of Title II funds is <u>made to individuals.</u>

In addition to professional development, Title IV funds may be used to reimburse a private school's purchase of supplemental enrichment materials, technology hardware and software, instructional materials and supplies, and other resources aligned to program purposes.



Title II & IV Guidelines: Contracted Services

For contracted services that <u>do not exceed \$3,000 per</u> full day of service, a contract shall be submitted for review at the time of the request. If a contract is not available to submit for review at the time of the request, a detailed scope of work or proposed contract of services must be provided. The submission must include a purpose, rationale, projected number of individuals to be served and a cost breakdown of the services to be performed to determine if the request is allowable, reasonable and necessary. Materials to support the services may be requested as an additional expense. Any contracted service requested in excess of \$3,000 per full day of service, including travel, will be presumed unreasonable.



Title IV Guidelines: Technology Cap

No waiver of the 15% Technology Cap for 2021-22.

No more than 15% of funds for the effective use of technology category for hardware, software, or digital content.

• TECHNOLOGY CAP *EXAMPLE*

- The creation of a credit recovery or advanced course. An LEA created an advanced algebra course for middle school students completing Algebra I.
- Teachers receiving a supplement to serve as a technology coach at their school
- Student and parent sessions to show them how to access virtual materials.
- STEM materials/supplies.
- \$2000 (above activities) x 15% =

\$300 is the maximum budget CAP for hardware and software


