QUALIFICATIONS:

Graduation from a standard high school or possession of a GED_and a minimum of 3 years experience as an educational or community interpreter. Must possess a score of 3.0 – 3.4 on the Educational Interpreter Performance Assessment (EIPA) and passing the EIPA Written Test.

PREFERRED:

Associate's degree from an accredited college or university in interpreting/sign language or related field and a minimum of one year an educational or community interpreter.

MAJOR FUNCTION

Provides sign language interpreting for students who are deaf or hard of hearing (as documented on their IEP's), and for adults with hearing loss (as requested), based on the preferred language of the individual consumer. This will occur in slower-paced interpreting situations where there are occasional opportunities to ask for repetition or clarification and limited complex terminology or concepts are included.

ESSENTIAL RESPONSIBILITIES

- Provides receptive and expressive communication access for students who are deaf or hard of hearing through interpreting, as indicated on their IEP's, in both academic settings and at schoolrelated activities.
- Supports opportunities for students who are deaf or hard of hearing to fully participate in classroom discussions and social interactions.
- Serves as a language model for students who are deaf or hard of hearing for oral and signed communication.
- Provides student support, under the direction of the classroom teacher, by previewing or reviewing classroom instructional information.
- Shares relevant information about the DHH student's classroom performance, communication needs and social/emotional functioning with appropriate members of the educational team in a professional and objective manner.
- Participates in IEP meetings as an active member of the IEP Team.
- Collaborates with school staff to support the appropriate delivery of IEP accommodations.
- Provides communication access for adults who are deaf or hard of hearing during PCS meetings and events, as required by the Americans with Disabilities Act (ADA).
- Establishes and maintains positive and professional relationships with all stakeholders.
- Establishes, in conjunction with the appropriate stakeholders, a physical setting (lighting, noise level, distance, line of sight) that promotes effective interaction and communication.
- Prepares for interpreting assignments, when possible, by acquiring, reviewing and researching topics/materials being covered.

ESSENTIAL RESPONSIBILITIES (Continued)

- Performs all job duties under the guidelines of the Registry of Interpreters for the Deaf/National Association of the Deaf (NAD-RID) Code of Professional Conduct and the EIPA Guidelines of Professional Conduct for Educational Interpreters.
- Maintains required confidentiality of personal information about students and staff.
- Maintains professional boundaries when communicating with consumers and coworkers.
- Demonstrates professionalism by participating in relevant trainings and working toward upgrading interpreting credentials.
- Performs other related duties as required

TERMS OF EMPLOYMENT

Salary and benefits shall be paid consistent with the district's approved compensation plan. Length of the work year and hours of employment shall be established by the District.

Performance of the job will be evaluated in accordance with provisions of the School Board's policy on evaluation of personnel.
