QUALIFICATIONS:

Demonstrated functional literacy at a level required to follow given oral and written instructions necessary to perform the above mentioned duties and responsibilities. Possession of a valid State of Florida Class E noncommercial driver's license.

PREFERRED:

Some experience in operating commercial mowers and other grounds maintenance equipment.

MAJOR FUNCTION

Performs unskilled and semi-skilled manual work in assisting with overall outside grounds maintenance and upkeep. Duties are varied, may be routine, and may include assisting with laboring tasks such as clearing undeveloped land for future construction. Work is performed under direct supervision and is reviewed in progress and upon completion.

ESSENTIAL RESPONSIBILITIES

- Operates push mowers, rider mowers, tractors, and similar equipment in the cutting of lawns, fields, play areas, embankments, and gullies.
- Trims and cuts shrubbery, bushes, hedges, trees, using hand and power equipment such as hedge trimmers, chain saws, and pole saws.
- Removes weeds by hand, with a power weed eater, or through chemical application; edges, rakes, sweeps, cleans out ditches and retention ponds, lays sod and moves dirt; sprinkles and fertilizes grass as needed.
- Picks up trash and other debris from lawns, driveways, outside walkways.
- Assists with maintenance of flower beds including planting, weeding, fertilizing, and watering.
- Assists in clearing undeveloped land for future construction.
- · Assists in the minor repair and maintenance of groundskeeping equipment.
- Applies knowledge of hazards and safety precautions in the performance of job duties.
- Assists with loading/unloading trucks and moving furniture between sites.
- · Work may involve the lifting of heavy objects regularly and occasional climbing.
- Performs other related duties as assigned.

TERMS OF EMPLOYMENT

Salary and benefits shall be paid consistent with the district's approved compensation plan. Length of the work year and hours of employment shall be established by the District.

Performance of the job will be evaluated in accordance with provisions of the School Board's policy on evaluation of personnel.

The above statements are intended to describe the general nature and level of work being performed by employees assigned to this classification. They are not intended to be construed as an exhaustive list of all responsibilities and duties required of those in this classification.
