# SUPERVISOR, FOOD SERVICES (FINANCIAL/SPECIAL PROJECTS)

#### **MAJOR FUNCTION:**

Performs supervisory work in planning, organizing, coordinating and monitoring finance/special projects and programs within of the Food Service Department.

- Prepares and evaluates the monthly profit & loss statements for the food service operation.
- Prepares "break-even point" statements for all schools operating in the "red;" trains managers to use them.
- Prepares revenue and participation reports for Food Service Field Specialist to use in staffing.
- Assists Systems Analyst (Food Service) with integrating SNAP accounting system into district MIS system.
- Oversees free & reduced-price meal application verification process.
- Supervises, evaluates, trains and delegates work to assigned staff.
- Coordinates staff development activities as needed.
- Assists director and other supervisors with other Food Service duties, as needed.
- Performs other related duties as required.

#### **MINIMUM QUALIFICATIONS:**

Bachelor's degree from an accredited college or university in Accounting or Business Administration, with major course work in Accounting, or a related field. Five (5) years of professional experience in general and contracted project accounting work in a large school system or comparable environment to include two (2) years experience as a supervisor in a related business function. Must show evidence of a working knowledge of the principles of quality management or commit to begin training in the area of quality within the first six (6) months of employment.
