CABINETMAKER

MAJOR FUNCTION:

Performs skilled journeyman level finished carpentry work. Applies woodworking skills in the fabrication, modification and repair of cabinets, furniture, doors, and related items. Performs work in accordance with specifications and accepted standards and procedures of the trade. Assignments are received orally or through work orders. Work is performed independently, under general supervision, and reviewed through observation and results obtained.

DUTIES AND RESPONSIBILITIES:

- Interprets, adapts, and works from blueprints, technical drawings, rough sketches and oral and written instructions for cabinetwork construction and modification.
- Prepares work specifications; estimates project materials and requisitions same as needed for minor jobs.
- Maintains simple records and reports on time, materials used, and projects completed.
- Makes, constructs, redesigns, assembles and/or installs cabinets and related woodwork in buildings, vehicles and other locations as required.
- Operates and maintains hand, bench and power tools and machinery of the trade, such as band saw, dado saw, panel saws, commercial type radial arm and table saws, power miter box, routers, shapers, planers, mortisers, drill press and joiners.
- Prepares wood surfaces for finishing with varnish, paint or laminated plastics and veneers and applies the same; installs: hinges, drawer pulls and related hardware.
- Designs and constructs plexiglass signs, as needed. Performs general rough or frame carpentry work, as required.
- Lifts heavy objects or materials on a routine basis.
- Performs related work as required.

MINIMUM QUALIFICATIONS:

Graduation from high school or possession of a GED, plus four (4) years progressively responsible work experience in the cabinetmaking or millwork trade performing most of the above mentioned duties and responsibilities. The successful completion of up to two (2) years of verifiable formal training in the trade (vocational, military, or indentured apprentice school) may be substituted for a like amount of the experience requirement. Possession of a valid State of Florida Class E noncommercial driver's license, and any other license as may be required by law.
