DHMS will hold our annual meet the teacher night in Aug 2024. We will then have our Title 1 parent meeting Sept 2024, followed by our curriculum night nights in the Fall of 2024 and Spring 2025. DHMS will have course request selection nights for parents in the Fall of 2024 and Spring 2025. We will have out FAST Data nights Fall 2024 and Spring 2025 to assist our parents with understanding their student FAST data and ways to support their scholar academic achievement. We will also have our learning labs which will be held monthly to assist with schoolwide discipline procedures.

We will also offer learning labs that will engage in dialogue and create an action plan to help with student discipline here on campus. These meeting will be done monthly as well as our quarterly curriculum nights.

DHMS will address barriers to increase attendance and academic support at home by informing the parents/student about the power of instructional minutes that are missed throughout the school year. I believe there is power in providing documented data to show how much the correlation of missing school ties into academic success. This will be done during our parent nights while also providing parents with the opportunity to engage in hands on experiences to gain a deeper understanding of their scholar curriculum. Parents will also receive the technological piece on Focus to help with our online student portal.
